Personal data that we process

Sokkies processes your personal data because you use our services and / or because you provide them to us yourself. Below you will find an overview of the personal data we process:

1. First and last name (if provided by you to us)
2. Address details (if provided to us by you)
3. Telephone number (if provided to us by you)
4. E-mail address (if provided by you to us)
5. Bank account number (if provided to us by you)
6. Other personal data that you actively provide, for example in correspondence and by telephone
7. Information about your activities on our website
8. IP address
9. Internet browser and device type
10. Bank account

Special and/or sensitive personal data that we process

Our website and /or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us via info@sokkies.nl and we will delete this information.

For what purpose and on what basis we process personal data

Sokkies processes your personal data for the following purposes:

1. Handling your payment.
2. Sending general communications regarding our services or offers.
3. To be able to call or e-mail you if this is necessary to be able to perform our services.
4. To inform you about changes to our services and products
5. To deliver goods and services to you.
6. Sokkies analyzes your behavior on the website in order to improve the website .
7. Sokkies also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision-making

Sokkies does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions that are taken by computer programs or systems, without involving a person (for example, an employee of Sokkies).

How long we store personal data

Sokkies does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data:

Sharing personal data with third parties

Sokkies shares your personal data with various third parties if this is necessary for the execution of the agreement and to comply with any legal obligation. With companies that process your data on our behalf, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Sokkies remains responsible for these processing operations.

Cookies, or similar techniques, that we use

Sokkies uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Sokkies uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered.

These cookies are also used to make the website work properly and to optimize it . On your first visit to our website, we have already informed you about these cookies and asked for permission to place them. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via the settings of your browser. View, modify or delete data

To ensure that the request for access has been made by you, we ask you to send a copy of your identity document with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
